3. **Tryouts:** Tuesday - Thursday: Oct. 3-5th and Oct 10th - 12th - Monday Oct. 16th. 3rd thru 8th Grades will travel. K-2 will be skills and drills. Teams will enter B or C only unless otherwise determined.

- A. Sr Tryout should consist of live play and less drills
- B. All athletes must attend one tryout to be drafted by coaches. Non attendees will be placed at the end of draft
- C. Coaches will not be given a level until tryout/draft process
- D. Draft - 2 drafting coaches and two board members only
- E. No draft is final without board approval
- F. Players cannot be moved once draft is complete without Board approval
- G. Board will accept a Non Coaching request from Jr/Minor Levels w/Board approval
- H. A Board member will talk with all parents at tryouts - Practice Schedule and Athlete playing time to be address

Coaches Application and Equipment Deposit - \$75 Refundable when equipment is returned.

- A. Approved - \$50 Refundable Equipment Fee
